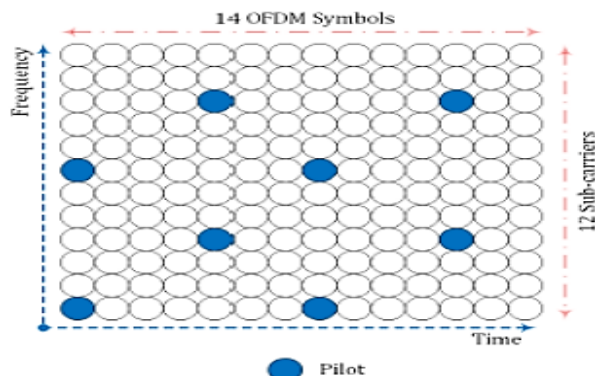


Figure 1:- An example of the time-frequency resource grid for LTE-A
